Updates to Basic Training for Personal Safety and Social Responsibilities (PSSR)

1. Minimum Standards of Competence in Personal Safety and Social Responsibilities (PSSR)

The 108th Meeting of the IMO's Maritime Safety Committee approved amendments to STCW Table A-VI/1-4 – 'Specification of minimum standard of competence in personal safety and social responsibilities (PSSR)'. These amendments take into account the recommendations of the ILO/IMO Joint Tripartite Working Group (JTWG) which identified violence and harassment, including sexual harassment, bullying and sexual assault as one of the most significant issues facing seafarers today.

The amended Table A-VI/1-4 introduces a new competence which aims to ensure seafarers have basic knowledge and understanding of violence and harassment including sexual harassment, bulling and sexual assault. The insertion to the table is shown on the following page.

The new competency requirement will enter into force on 1 January 2026. From this date, the new requirements shall apply to seafarers who are undertaking their PSSR qualification.

Seafarers who have completed their PSSR training prior to 1 January 2026 are not required to update their training. However, it is recommended to ensure that current PSSR holders are made aware of the latest standard which could be achieved by either internal training or voluntarily attendance of an updated PSSR course.

Voluntarily updating to the latest PSSR standards will enhance crew welfare by providing seafarers with tools to prevent and respond to violence and harassment on board, supporting the mental and physical well-being of all seafarers.

As indicated in MSN 050, where PSSR training is required, it may be taken online and the course may be approved by any STCW Whitelist country.



Contribute to the prevention of and response to violence and harassment², including sexual harassment, bullying and sexual assault

Prevention of violence and harassment:

Basic knowledge and understanding of violence and harassment, including sexual harassment, bullying and sexual assault, and the continuum of harm

Basic knowledge and understanding of the consequences of violence and harassment, including sexual harassment, bullying and sexual assault on victims, perpetrators, bystanders and stakeholders, and its effects on safety, health and well-being

Understand that, among others, abuse of power relations, discrimination, stress, isolation, fatigue, drugs or alcohol may contribute to violence and harassment, including sexual harassment, bullying and sexual assault

Responding to violence and harassment:

Ability to identify violence and harassment, including sexual harassment, bullying and sexual assault

Basic knowledge of the action to take to intervene in and report violence and harassment, including sexual harassment, bullying and sexual assault

Understand the basic principles of trauma-informed response and how to provide appropriate support to a victim, bystanders and self

Assessment of evidence obtained from approved instruction or during attendance at an approved course Acceptable practices and procedures designed for the prevention of violence and harassment, including sexual harassment, bullying and sexual assault are observed at all times

Able to identify violence and harassment, including sexual harassment, bullying and sexual assault, and the continuum of harm and its effects

Acceptable practices and procedures designed for the intervention in and reporting of violence and harassment, including sexual harassment, bullying and sexual assault are

observed at all times
