1. Introduction

This notice serves to highlight shipowners of recent trends identified following Port State Control Inspections performed across all Manx flagged vessels for September & October 2024.


The top risk areas identified were:

- Life Saving Appliances
- Ship Certificates
- Fire Safety
- MLC Conditions of Employment
- MLC Health Protection, Medical Care, Welfare and Social Security Protection

The Ship Registry advises owners to place particular emphasis on these risk areas during their own inspections to minimise issues during Port State Control. Any concerns/issues following Port State Control should be highlighted to the Ship Registry as soon as possible.
